**Sub: Transmission of O.K. message during General Election to Urban Local Bodies.**

Madam/Sir,

I am directed to say that the O.K. messages are required to be sent by the Election Officer to the Commission at different stages during General Election to Urban Local Bodies. These messages shall be sent to the Commission by the Election Officer during specified time mentioned below without fail on the day of poll, before.

**A. Day Before Poll**

- i) By 3 PM on the day of dispersal  
“All polling parties are dispersed with their election materials”.
- ii) By 7 PM on the day of dispersal  
“All Polling Parties have reached their destination safely”.
- iii) By 9 PM on the day of dispersal  
“All election materials including EVM are OK with all Polling Parties”.

**B. Day of Poll**

- i) By 9 AM on the day of poll  
“The poll has commenced in all the Polling Stations”.
- ii) -Poll percentage on two hourly basis  
a) 10.30 A.M b) 12.30 P.M c) 02.30 P.M d) 04.30 P.M
- iii) By 6 PM on the day of poll  
“The Poll has been completed in all the Polling Stations smoothly”.
- iv) By 8 PM on the day of Poll  
“All the polling parties have safely reached the Collection Centre with polled EVMs”.
- v) By 10.00 PM on the day of Poll:  
“All EVMs and Statutory Papers are kept in the Strong Room”.

**C. Day of Counting**

(i) By 8.30 AM on the day of Counting:  
"Counting has started peacefully".
