- i) In the identity slip the candidate's photograph is to be affixed. Each candidate is required to furnish photograph in duplicate **within 3 days** from the date of publication of final list of contesting candidates.
- ii) The Election Officer shall prepare the Identity Slip and put his signature attesting the photograph in a manner that half of his signature also covers the Identity Slip.
- iii) Identity slip is to be prepared in duplicate out of which one will be kept in the record of the Election Officer and other will be issued to the candidate after obtaining his due acknowledgement on the body of the office copy and the acknowledgement is to be attested by the Election Officer or Officer authorised by him.

This should be brought to the notice of all candidates.
