

**INFORMATION ON GENERAL
ELECTION TO URBAN LOCAL BODIES
IN ODISHA
2013-14 & 2014-15**

INTRODUCTION

The General Election to the Urban Local Bodies held in 2013 was the 4th General Election after constitution of the State Election Commission in 1994. The earlier elections were held in the year 1998, 2003 and 2008. Generally, the election to Urban Local Bodies (ULBs) in Odisha were being held in different phases, owing to different reasons. The election to Kendrapada Municipality whose delimitation and reservation was challenged in the Orissa High Court is being held in isolated manner.

2. The election was conducted basing upon the Act and Rules framed under Odisha Municipal Act, 1950 and Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 in respect of 90 Municipalities and NACs and Odisha Municipal Corporation Act, 2003 and Odisha Municipal (Division of City into Wards, Reservation of Seats and Conduct of Election) Rules, 2003 in respect of Berhampur, Cuttack and Bhubaneswar Municipal Corporations.

3. There were 94 ULBs including 3 Municipal Corporations during 2013-14 and 2 ULBs during 2014-15 in the State for which the Commission conducted poll. During the election process starting from August, 2013 to July, 2014 elections were held to 90 Municipalities and NACs and 3 Municipal Corporations in 6 different phases. Due to proposals by the State Government to constitute Rourkela Municipal Corporation and Sambalpur Municipal Corporation election could not be held in 2 Municipalities, i.e., Rourkela Municipality & Sambalpur Municipality and 2 NACs, i.e., Hirakud NAC and Burla NAC. Elections to Paradeep Municipality, Belpahar Municipality, Sunabeda Municipality, Balimela NAC were due in April, 2015 and Redhakhol NAC in May, 2015. Elections to Kendrapada Municipality is due in November 2016. Elections to Hindol, Attabira and Nuapada NACs are due in April, 2018.

4. Elections to Urban Local Bodies starts with Delimitation of Wards and Reservation of Seats. This work is done by the State Government through the District Magistrates. For holding General Elections to 96 Urban Local Bodies including three Municipal Corporations, this Commission in the month of October, 2012 asked the Government in Housing & Urban Development Department to complete the entire process by the 31st January 2013. It is to be mentioned that in 2008 election was held for Berhampur Municipality which was upgraded to Municipal Corporation after the election and was included in the list of Municipal Corporations for the first time in 2013. On the request of the State Government, the Commission allowed extension of time up to 15th February, 2013 to complete the Delimitation of Wards and Reservation of Seats.

5. In the meanwhile the Government issued the schedule for Delimitation of Wards and Reservation of Seats of 93 Urban Local Bodies except three Municipal Corporations.

The Government in H. & U.D. Department intimated that proposals have been received from the Municipal Corporations to conduct elections on the basis of Census Report, 2011. It is worth mentioning that the primary Census data which was the basic ingredient for Delimitation of Wards was not available by December, 2012. This Commission asked the Government to complete the Delimitation of Wards and Reservation of Seats of Berhampur Municipal Corporation latest by the 15th March 2013 for which the election was due in September, 2013 and in case of Bhubaneswar Municipal Corporation and Cuttack Municipal Corporation the dates for final Delimitation of Wards and Reservation of Seats were extended up to the 30th April 2013 and the 30th June 2013 respectively.

6. The Commission while intimating these dates also brought it to the notice of the Government that the Commission has no definite opinion about the Census Report, 2011. The ultimate purpose of the Commission is to complete the election before the end of the tenure and the Government is supposed to co-operate with Commission in this regard. The confusion caused for the Census Report, 2011 delayed everything and the State Election Commissioner had to bring the matter to the notice of the Chief Minister on July, 2013 to complete the Delimitation of Wards and Reservation of Seats of Bhubaneswar & Cuttack Municipal Corporations with Census Report, 2001 as any further delay would lead to a Constitutional deadlock.

7. The District Magistrates of the concerned Districts completed the Delimitation of Wards and Reservation of Seats of Councillors for 93 ULBs by the 15th February 2013 and the reservation of office of the Chairpersons of these 93 Urban Local Bodies were finalised by the Government on the 21st February 2013. The Delimitation of Wards and Reservation of Seats as well as the reservation of the post of the Mayor of Berhampur Municipal Corporation were finalised by the H. & U.D. Department on the 15th March 2013 and the 27th April 2013 respectively.

8. The Delimitation of Wards and Reservation of Seats of the Bhubaneswar and Cuttack Municipal Corporations were delayed to such an extent that the Commission was constrained to issue an order under Article 243-ZA of the Constitution of India directing the State Government to complete the said work in respect of Bhubaneswar Municipal Corporation by the 27th July 2013 and Cuttack Municipal Corporation by the 31st August 2013. Ultimately the Delimitation of Wards and Reservation of seats of Bhubaneswar Municipal Corporation was finalised by the Government on the 24th August 2013 and Cuttack Municipal Corporation on the 31st August 2013 basing upon the Primary Census Data of 2011 Census. The reservation of the post of Mayors of B.M.C. and C.M.C. were finalised by the Government on the 16th November 2013.

9. On completion of Delimitation of Wards and Reservation of Seats steps were taken by the Commission for the preparation of Electoral Roll. The Commission fixed the

1st January 2013 as the qualifying date for the enrolment of the voters in respect of 94 ULBs including Berhampur Municipal Corporation. For the election to Bhubaneswar Municipal Corporation the qualifying date was the 1st January 2013 which was subsequently amended as the 1st January 2013 with the latest date subsequently published by the Election Commission of India in July, 2013. For the Cuttack Municipal Corporation the latest supplementary Assembly Electoral Roll published by the Election Commission of India in July, 2013 and currently in force was adopted as the basis for preparation of Wardwise Electoral Roll.

10. As many as 90 cases were filed challenging Delimitation of Wards and Reservation of Seats in the Hon'ble High Court. In most of the cases the Hon'ble High Court granted interim stay and thereby further proceeding so far as conduct of election is concerned was stalled.

11. When the Commission wrote to the H. & U.D. Department to issue Notification under Section 12(2) of the Odisha Municipal Act, a Statutory Notification by the State Government calling upon the electorate to elect their Councillors/Corporators, the Government asked for further extension of time specified by the Commission as the number of cases and the interim orders passed had piled up. The Commission examined the matter at their level and intimated the Department that issue of notification by the State Government is a mandatory direction of the Commission as per the statute provided in the Odisha Municipal Act and the Government is duty bound to issue such notification on the date specified by the Commission. So, the Commission reiterated that the Notification shall be issued on the date specified earlier in those cases only where the Hon'ble High Court have not passed interim order.

12. When the matter stood thus the matter was taken up by the Commission before the Hon'ble High Court with a prayer that all the interim orders passed should be vacated as the tenure of the bodies were going to expire and the election is imminent. The Standing Counsel of the Commission argued the matter before the Hon'ble High Court and the Hon'ble High Court made an analogous hearing of all the cases relating the Municipal Election. Ultimately all the stay orders were vacated. Subsequently, the Commission asked the State Government to issue notification on the 8th August 2013 in respect of 90 Urban Local Bodies which were going to poll in September, 2013.

13. The Government in H. & U.D. Department issued Notification under Section 12(2) of the Odisha Municipal Act, 1950 on the 8th August 2013 calling upon the electorates to elect their Councillors. The Commission on the 12th August 2013 issued schedule for holding election for 90 Municipalities/NACs whose tenure were going to expire in September, 2013. In response to the said Notification of the Commission there was a mass agitation in 9 Districts of Odisha in the western part of the State for a separate Bench

of High Court and when the election process started, filing of nomination was boycotted in several places. Even though in a few places where nomination filing process continued for a day or two, it got disrupted before the completion of the process. In Padampur NAC of Bargarh District where the nomination process was peaceful the election process was disrupted from the stage of scrutiny of Nomination and ultimately poll could not be held on the scheduled date. Therefore in the first phase Elections to 65 Municipalities/NACs and Berhampur Municipal Corporation were held on the scheduled date, i.e., the 19th September 2013 and first meeting to elect the Chairperson/Mayor of these 66 Municipalities/NAC/ Corporation was held on the 30th September 2013 and thus the new Bodies were constituted on the scheduled date and time.

14. In the meanwhile the Government in H. & U.D. Department intimated on 8th October 2013 that steps were being taken to constitute Sambalpur and Rourkela Municipal Corporation. The Government published draft notification on the 15th November 2013 converting the Rourkela Municipality and some rural areas into Rourkela Municipal Corporation, merging Burla NAC, Hirkud NAC and some rural areas with Sambalpur Municipality to constitute Sambalpur Municipal Corporation.

15. Thus out of the 90 Municipalities and NACs for which notification was issued by the Commission on the 12th August 2013 elections were held in 65 Municipalities/NACs on the scheduled date leaving 25 Municipalities/NACs. Out of the said 25 ULBs two Municipalities (Rourkela Municipality and Sambalpur Municipality) and one NAC (Hirkud NAC) were converted into Municipal Corporations thus leaving 22 Urban Local Bodies for which the poll was to be held. The Commission again issued schedule on the 21st October 2013 for holding elections in these 22 Urban Local Bodies. Elections were held smoothly in 20 out of 22 ULBs and in two ULBs namely Balangir and Titilagarh Municipality election could not be held due to continuing agitation by the Lawyers and Public. Ultimately elections to these two ULBs were held on the 1st July 2014 as per the Commission's Notification issued on the 26th May 2014.

16. So far as the Bhubaneswar Municipal Corporation and Phulbani Municipality and G. Udayagiri NAC are concerned the new Local Bodies were to be constituted on or before the 10th December 2013. The elections to Phulbani Municipality and G. Udayagiri NAC were held on due date and the first meeting to elect Chairperson was held on the 9th December 2013. In case of Bhubaneswar Municipal Corporation the Delimitation of Wards and Reservation of Seats were already delayed due to non-availability of the Census Report in time. This Commission took honest steps to prepare the Electoral Roll in time to complete the election before the scheduled date. While the preparation of Electoral Roll was going on the Cyclonic Storm "Phailin" occurred and it affected the preparation of Electoral Roll on

the scheduled date. Further, large scale omissions and commissions in the preparation of Electoral Roll of B.M.C. were brought to the notice of Commission by various political parties and individuals and the Commission in order to ensure an error free Electoral Roll extended the time for field enquiry of the objections received. Thus the election to B.M.C. could not be held in time and the new Body which was to be constituted on the 10th December 2013 ultimately came into existence on the 17th January 2014. The elections to Cuttack Municipal Corporation and Baripada Municipality were held in time and the new Bodies took over on the expiry of the tenure of the previous Bodies.

17. Another development during the election process is worth noting. The Government in H. & U.D. Department on the 8th August 2013 issued Notification calling upon the electorates of 90 ULBs to elect the Councillors. The Commission first issued notification on the 12th August 2013 but elections could be held only in 65 ULBs out of the 90. When the Commission again issued notification in respect of 22 ULBs out of the balance 25 on the 21st October 2013 a question was raised, though not on record, regarding further notification by the State Government calling upon the electorate to elect Councillors in respect of the 22 ULBs for which election notification was issued on the 21st October 2013. The Commission examined the matter and found that since the notification was already issued by the State Government once and the election that being held for the second time was postponed for reason beyond control, there was no necessity for the Government Notification for the 2nd time. The Commission also took the same stand while issuing notification for Balangir and Titilagarh Municipality in May, 2014.

18. For the first time production of Caste Certificate along with the Nomination Form issued by the competent authority was made mandatory. It was also made categorical that non-submission of Caste Certificate by a candidate shall lead to rejection of candidature.

19. Elections to the Municipalities have been held by using Electronic Voting Machines (EVMs) since 2008. As per the practice, the Election Commission of India provides 75% of the total requirement of EVMs and the Commission have its stock of balance 25%. Since the elections have already staggered to different phases in 2008 and the elections to the Assembly and Parliament were round the corner it was decided that election to 90 ULBs and Berhampur Municipal Corporation would be held by using EVMs to be supplied by the ECI. The 25% stock available with the Commission was utilised for the election to Bhubaneswar Municipal Corporation, Cuttack Municipal Corporation and others which were proposed to be held later.

20. First the matter was taken up with the ECI to lend 3,850 number of EVMs even though the ECI had already issued a general order that EVMs available with ECI will no more be spared to the State Election Commissions in view of the General Elections to Parliament and Assembly. The Election Commission of India agreed to lend the required number of EVMs on personal contact of the State Election Commissioner. The transfer of EVMs has become more streamlined this time than the previous occasion. The ECI allowed the entire stock of 3,850 EVMs to be lifted from the single point from, i.e., the District Godown at Chhatrapur. The staff of the Commission camped at Chhatrapur and the required numbers of EVMs to 29 Districts were dispatched from that point. This was done smoothly and the 25% stock available with the Commission was used in subsequent elections.

21. Meetings were held with the representatives of the political parties and senior officers of the State Government for better co-ordination for conduct of election. Meetings were held with the political parties on the 28th February 2013 before the preparation of Electoral Roll and on the 14th August 2013 for smooth conduct of the poll. Similarly meeting was held on the 21st August 2013 with all the District Magistrates and Superintendents of Police in which senior officers of the State Government like Chief Secretary, D.G. & I.G. of Police, Home Secretary, Secretary, H. & U.D. Department and seniormost Police Officers of the State Government were present.

22. All forms, envelopes, labels and ballot papers for General Election to ULBs were printed at Government Press, Odisha, Cuttack. For the first time all statutory, non-statutory forms, labels were printed in Odia in order to facilitate the contesting candidates and these were supplied to the District much in advance.

23. Election Observers and Expenditure Observers were appointed by the Commission to ensure free and fair elections. Election Observers were assigned general

supervision of the election process and Expenditure Observers were appointed to monitor the ceiling on election expenses by the Commission. For this, 14 I.A.S. Officers and 18 O.A.S. Officers in the rank of Additional Secretary to Government were appointed as Election Observers. Similarly, 18 O.F.S. Officers in the rank of Deputy Secretary to Government and above were appointed as Expenditure Observers. But, for the elections held on the 22nd November 2013, the 2nd December 2013 and the 1st July 2014 the Commission appointed local O.A.S. Officers as Expenditure Observers, due to shortage of O.F.S. Officers.

24. Arrangements were made for 34,41,416 voters to exercise their franchise for electing 1,511 Councillors and 166 Corporators. The overall poll percentage was 60.93% compared to the poll percentage of 56% during the General Elections to ULBs held in 2008. A sum of Rs. 6,86,51,534 was spent towards conduct of election out of which Rs. 90,55,045 was given to D.G. & I.G. of Police for maintenance law and order.

25. During the process of election, election to Ward No. 15 of Bhuban NAC was countermanded due to the death of the contesting candidate. Re-poll was ordered in Ward No. 20 of Vyasaganar Municipality due to wrong printing of Ballot Papers which was detected on the day of poll.

26. Model Code of Conduct came into force with the declaration of the poll schedule by this Commission in respect of those ULBs. There was complete ban on announcement of any policy decision by the State Government. The Union Ministries were also informed through the Resident Commissioner not to announce any “Odisha specific” policy which had a direct bearing on the electorate.

27. During the enforcement of Model Code of Conduct several instances of violation came to the knowledge of the Commission. As a coercive measure the Commission recommended for the transfer of one District Magistrate and two Police Officers in charge of the Police Stations. The Commission also directed for filing of FIR against the office of one Minister and the conduct of another Minister was condemned.

28. The Commission would like to place on record the co-operation received from the Political Parties, District Administration, Police Department, Electronic & Print Media for conduct of smooth and fair poll. The Commission would also acknowledge support provided by the State Government in the smooth conduct of the election.

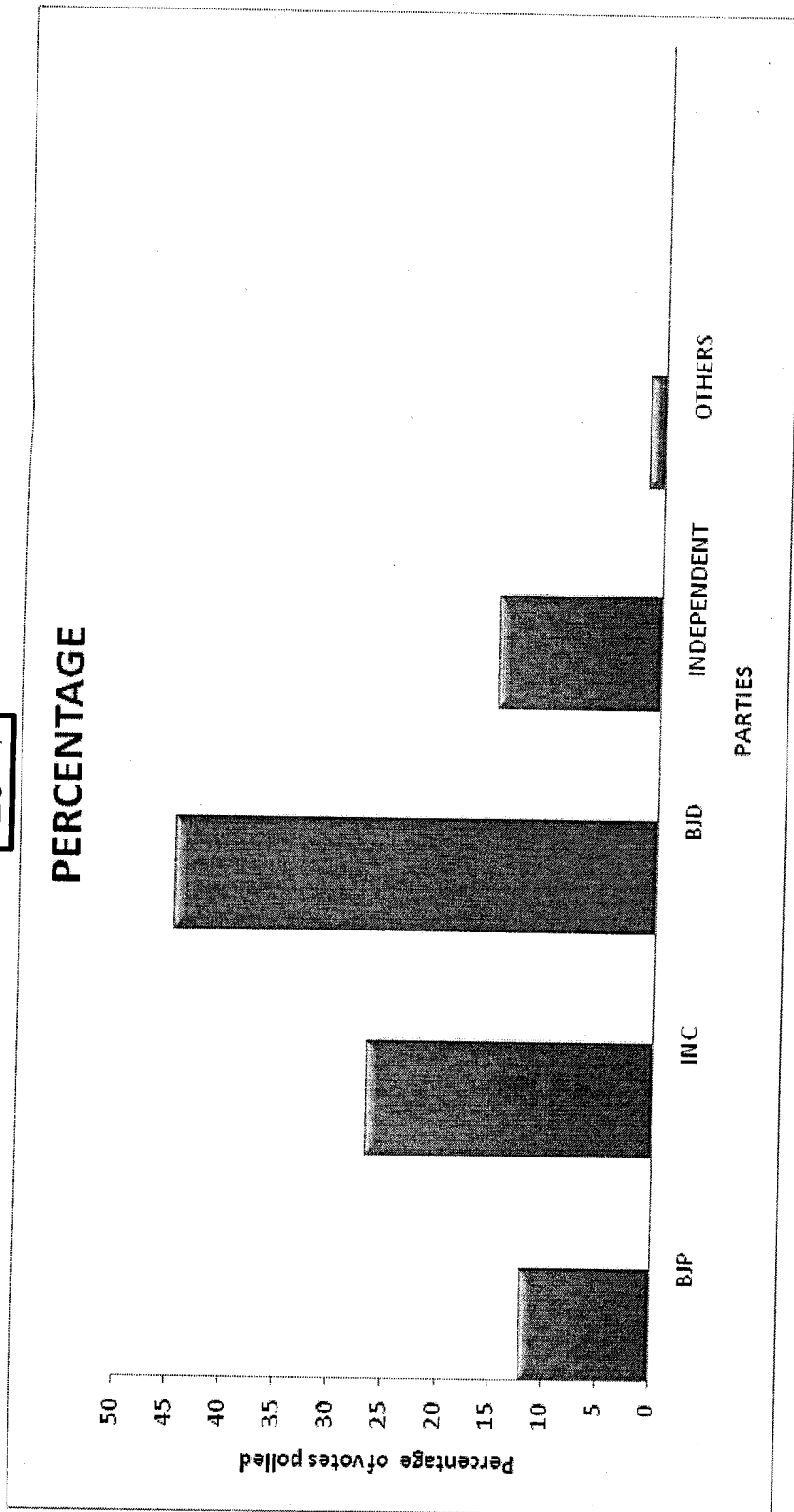

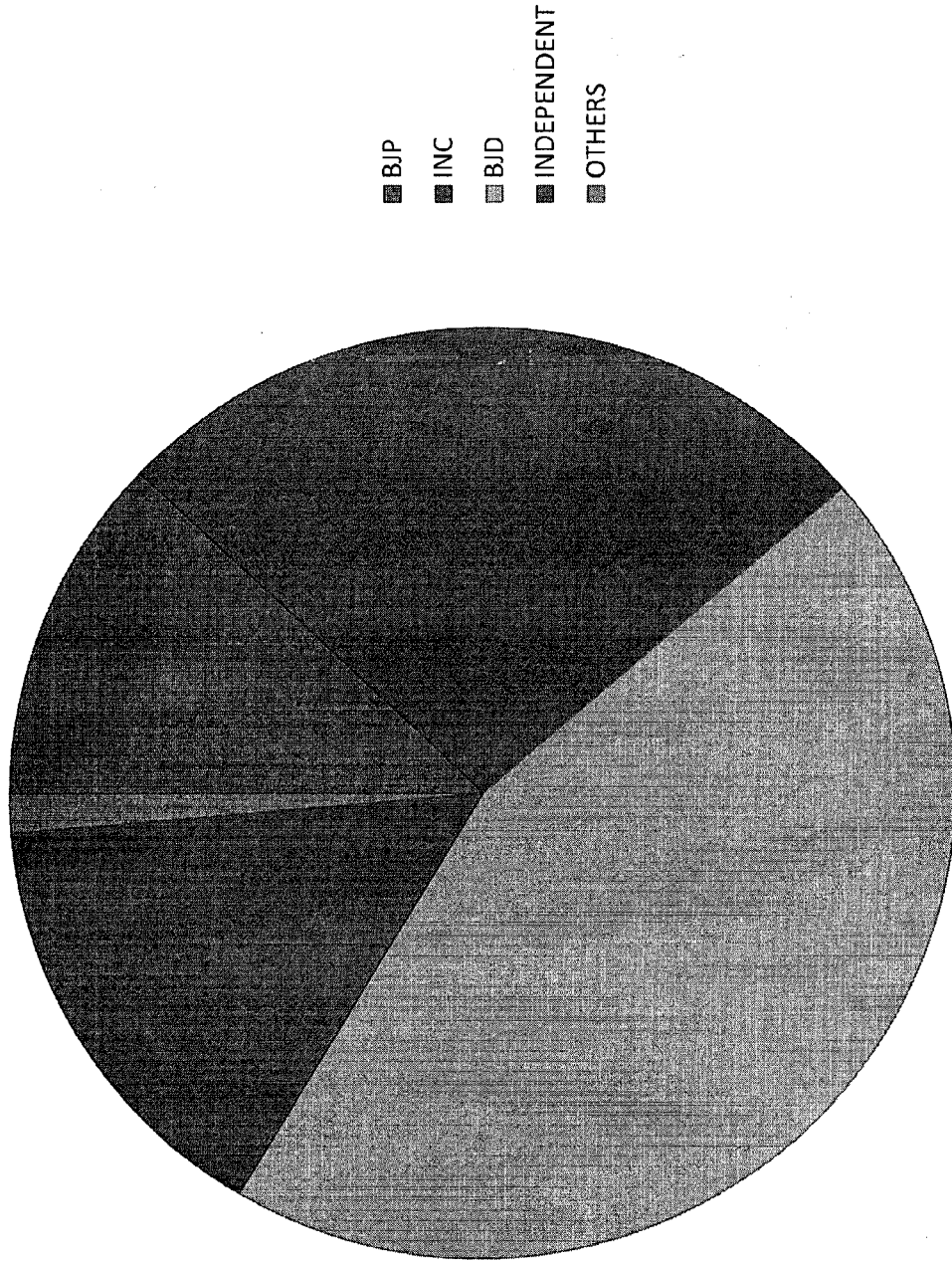
