FOREWORD

The State Election Commission, Odisha conducted fourth General Election to three-tier Panchayati Raj Institutions (PRIs) in the month of February, 2012. Schedule was drawn for holding General Elections from the 11th February 2012 to the 19th February 2012 to elect 854 Zilla Parishad Members, 6235 Sarpanches, 6235 P. S. Members and 87,528 Ward Members excluding Sarpanch and 23 Ward Members of Dinkia Gram Panchayat in Ersama Block of Jagatsinghpur as their tenure was to be completed in 2014. Elections were held simultaneously in all the 30 Districts in five phases. Indirect election to the office of Naib Sarpanches were held on the 10th March 2012, such election to the office of Chairman of Panchayat Samiti and President of Zilla Parishad were held on the 11th March 2012 and the 13th March 2012 respectively.

2. The preparation for General Elections to PRIs starts in the Commission almost one year before the date of actual election. The Commission with its skeleton staff makes elaborate preparations so that the election can be held smoothly. Since responsibility for the conduct of free and fair election is the prerogative of the Commission, the Commission makes comprehensive arrangements. The arrangement includes meeting with the Political Parties, Collectors, Superintendent of Police, all the top officials of the civil and police administration, preparation of manual, printing of ballot papers, procurement and supply of election materials and proper co-ordination between the field and the Commission.

3. For conduct of General Election, the Commission started the preliminary work from January 2011 and as a first measure convened a meeting of District Panchayat Officers on the 21st January 2011 for preparatory works i.e. to assess the stock position of election materials, availability of polling personnel, vehicle, official staff requirement of funds etc. for General Election to Panchayati Raj Institutions.

4. As the first step, the Commission recommended to the State Government to complete the task of Delimitation of Wards and Constituencies and Reservation of Seats by the 30th April 2011. The Government sought for extension of time up to the 30th July 2011 to complete the process but the Commission extended the time up to the 15th July 2011.

5. There were increase of two Gram Panchayats and 9 Wards in the delimitation done in 2011. Two G.Ps. namely Anara in Hatadihi Block of Keonjhar District and Bajrakote in Ranapur Block of Nayagarh District were constituted. Out of 9 Wards 5 Wards were in newly formed Anara G.P. and four new Wards were constituted in Trijanga G.P. of Dangadi Block in Jajpur District. Thus total Gram Panchayats and Wards became 6236 and 87551 respectively.

6. Accordingly the State Government in Panchayati Raj Department completed the reservation of seats for Zilla Parishad Members and Collectors of different Districts completed the reservation of seats for Ward Members, Sarpanch and Panchayat Samiti Member by the 15th July 2011.

7. Upon receipt of the reservation of seats from the Districts steps were taken for finalisation of polling stations. The Commission issued instructions to reduce the numbers of temporary structures, avoid Kothaghars, Community Centers and religious places for polling booths.

8. After completion of Delimitation of Wards, Reservation of Seats and finalisation of polling station the Commission took steps for preparation and printing of Electoral Roll. Initially it was ordered to complete preparation including printing of Electoral Roll on the 3rd December 2011, but due to high flood situation in the State the Commission extended the schedule to the 9th December 2011. For this the Commission revised the Electoral Roll Programme Schedule.

9. Panchayat laws lay down that Electoral Roll for Assembly Constituency for the time being in force shall be the basis for the Electoral Roll for Panchayat Election unless State Election Commission directs otherwise. As the Assembly Electoral Roll for 2012 was due for publication in January/February, 2012 by the Election Commission of India, it was not possible on the part of State Election Commission to conduct General Election to PRIs before February, 2012 basing upon the Electoral Roll for 2012. As such Electoral Roll published by the Election Commission of India in January, 2011 was the basis for preparation of Electoral Roll for 4th General Election to PRIs, 2012. The Commission fixed the qualifying date to the 1st November 2011 and it was instructed that those attaining the age of 18 years on the 1st November 2011 can file claims to enroll them as electors for the Panchayat Election, 2012. For preparation of Electoral Roll, the Commission convened a meeting of the political parties on the 10th August 2011 and had a deliberation with the representatives of political parties. It also convened a meeting of the District Collectors to impress upon them on preparation of error-free Electoral Roll.

10. Printing of Electoral Roll was done at District level under the supervision of District Collectors and funds were placed at their disposal for the purpose. When some irregularities on printing of Electoral Roll came to the notice of State Election Commission at a belated stage, instruction was issued to all Collectors to compare the Electoral Roll with Assembly Electoral Roll and get it corrected.

11. On the advice of the State Election Commission, the State Government issued notification on the 23rd December 2011 calling upon the electorate to elect their representatives to three-tier Panchayati Raj Institution in a General Election.

12. In order to complete the General Election to PRIs, 2012 before completion of tenure of last elected Panchayat Bodies the Commission notified the election schedule on the 24th December 2011 and the model code of conduct came into force from the same date till completion of direct election i.e. the 19th February 2012. As per Election laws, the Wards/ Constituencies where no nomination were filed and all nominations were rejected, the Commission notified fresh schedule to receive nomination for the second time on the 19th January 2012.

13. Election were held in 5 phases i.e. the 11th February 2012 to the 19th February 2012 with one day gap for each day of poll. Instructions were given to impart training at District Level and Block Level to the polling personnel/counting personnel and election related officers. For smooth conduct of poll, the Commission convened a meeting with political parties on the 16th December 2011. A meeting was convened on the 4th January 2012 to take stock of the preparedness including law and order where Development Commissioner, Principal Secretary, Home, D. G. & I.-G. Police, Director, Panchayati Raj Department and all the Collectors and Superintendents of Police and other senior officers participated.

14. All Ballot Papers, forms, envelopes, labels & Ballot Papers for General Election to PRIs were printed at Government Press, Odisha, Cuttack. All statutory, non-statutory forms, labels were printed in Odia, in order to facilitate the contesting candidates and these were supplied to the Districts much in advance.

15. The Commission changed the colour of Ballot Papers and prescribed light pink for Ward Member, green for Sarpanch, yellow for Panchayat Samiti Member and white for Z.P. Member. Ballot Papers were printed with watermark having Logo of SEC as a security measure. Ballot Papers of Ward Member, Sarpanch & Panchayat Samiti Member were dispatched to all districts by mid January, 2012. The Ballot Papers for Z.P. Members were dispatched to the district by the 5th February 2012.

16. To ensure free and fair election the Commission deployed 38 O.A.S. Officers as Election Observers. More than one Observer(s) were appointed for bigger and sensitive districts. They were asked to be present at District Headquarters during scrutiny, campaigning and also during the period of poll. As many as 32 Expenditure Observers were appointed to monitor the ceiling on Election Expenditure for candidates contesting for Sarpanch, Panchayat Samiti Member and Zilla Parishad Member. The Commission also fixed limit on use of no. of vehicles by the contesting candidates.

17. The Commission ordered for re-poll in 309 Wards due to wrong printing of ballot papers, booth capturing, destruction of ballot boxes and vitiation of free and fair poll. This includes 121 Wards of Khurda Zilla Parishad Zone No.3 of Khurda Block where polling was postponed due to wrong printing of Ballot Papers.

18. Arrangement were made for 2,44,82,765 voters to exercise their franchise in 87,551 (Booths) Wards in electing their representatives. Overall percentage of poll was 74.3%, which is 1.3% percentage more in comparison to General Election to Panchayats, 2007.

19. The Provision of (Extension to the Scheduled Areas) Act, 1996 came into force on the 24th December 1996. Odisha Gram Panchayat Act, 1964, Odisha Panchayat Samiti Act, 1959 and Odisha Zilla Parishad Act, 1991 have adopted the provisions of the PESA Act. It covers 7 districts i.e. Mayurbhanj, Sundargarh, Koraput, Malkangiri, Rayagada, Nawarangpur and Kandhamal in full

and Keonjhar, Gajapati, Kalahandi, Balasore, Sambalpur and Ganjam in part spread over in 1966 Gram Panchayat in 118 Blocks in full and 3 Blocks in part. Accordingly, 24734 Wards out of 87,551 Wards, 1966 office of Sarapanch out 6236, 1965 office of Panchayat Samiti Member out of 6235 and 256 Members of Zilla Parishad out of 854 comes under the Schedule Area. Elections to these offices were conducted as per the provisions of Panchayat Laws in vogue in strict conformity with of the PESA Act.

20. During the General Election to Panchayati Raj Institutions, 2012 some innovative and maiden steps were taken by the Commission as well as by the Government. The Government in Panchayati Raj Department for the first time introduced 50% reservation of seats for women candidates and it was also notified that the Delimitation and Reservation done for 2012 PRI election will continue for two terms. Hence, there will be no Delimitation and Reservation for General Elections to PRIs, 2017.

21. The Commission also made provision for submission of Caste Certificate mandatory along with nomination form. Earlier there was provision of submitting an undertaking for those contesting in reserved constituencies in case they do not have Caste Certificate issued by the competent authority. When it was found that large number of election petitions are being filed challenging the caste of an elected representative the Commission felt it necessary to make the provision of Caste Certificate mandatory along with the nomination form for those contesting to reserved offices.

22. Further, the Commission for the first time made the provision of *ex gratia* compensation for polling and police personnel. Earlier there was no such provision for those succumbing to death or facing accident during the election duties. The compensation was given as an accidental relief for mishap during election period. The Commission took this decision taking into consideration the prevailing law and order situation in the State.

23. The Commission also revised the ceiling on election expenses and the ceiling for Zilla Parishad Member has been revised to Rs.1.5 lakhs from Rs.75,000 and for Sarpanch and P.S.Member to Rs.60,000 from Rs.30,000.

24. No major poll violence took place during the election. The poll was conducted smoothly all over the State barring some minor incidents except in Kashipur Block in Raygada District. The people of Kashipur on the demand for inclusion of 'Jhodia' community in the list of Scheduled Tribe boycotted the poll. Even though initially nominations were filed the said nominations were withdrawn and thus Poll was boycotted in 3 Zilla Parishad Zone and 20 Gram Panchayats of Kashipur Block. The next course is the nominations of Members of respective bodies to be followed up by competent authorities.

25. The PRI Elections, 2012 was not far from controversy. The first controversy related to the decision of the Election Commission prohibiting the Political Parties aligning themselves with the candidates contesting to the offices of Sarpanch, P.S.Member and Ward Member. Even though

the law clearly mandates that election to the above offices shall be fought on non-political party basis there had been a practice for those contesting to the above offices to propagate/campaign in the banner of a political party. The political party in general were critical of the decision of this Commission. The matter went to the Hon'ble High Court of Odisha by one of the contesting candidate challenging the notification of the Commission. The Hon'ble Court in a *ex parte* hearing stayed the notification of the Commission. But, on hearing the Commission and the petitioner the Hon'ble Single Bench Court passed a very comprehensive order upholding the decision of the Commission. Then again the matter went to the Division Bench of the Hon'ble High Court and the Hon'ble Court again stayed the notification of the Commission.

26. The second controversy related to release of a *manifesto* by the Indian National Congress. The *manifesto* released in shape of a booklet contained the pictorial cartoon of the Chief Minister which was alleged to be the violation of Model Code of Conduct by the B.J.D. The State Election Commissioner after hearing both the parties held that the *manifesto* published by the I.N.C. violated the prescribed Model Code of Conduct and directed for its withdrawal from circulation.

27. During 2007 Panchayat Election, it was observed that counting of votes at the booths created a lot of problems which ultimately resulted in lot of litigations. The quality of counting also suffered and it had a direct impact on the conduct of free and fair election. The Commission repeatedly urged upon to amend the said rule and despite the best of efforts nothing could be materialised. During 2012 Panchayat Election the same situation resurfaced and all the repoll can be related to the counting at the booths. The ballot papers, ballot boxes were snatched away by the miscreants because of booth level counting. It is once again reiterated that this practice can be done away with as early as possible lest, it will be Herculean task to hold next Panchayat Election with the counting at the polling station.

28. The Commission place it on record the active co-operation received from Political Parties, District Administration, Police Department, Electronic & Print Media for the conduct of smooth and fair poll. The Commission also express its sincere thanks to the State Government for all the assistance it received in the smooth conduct of the election. Preparation of the compilation has been labour of love for all of us in the Commission.

29. The compilation is expected to be useful to the Political Parties, Government Department and N.G.Os. working in the areas of Panchayati Raj. We shall feel amply rewarded if the users find it truly helpful.
