- (ii) The above rate should exclude GST & other Taxes as applicable which will be borne by the bidder and shown separately.
- (iii) The successful bidder will deposit the price of the paper after weighment at the approved rate in shape of cash before lifting the shredded waste papers.
- (iv) The bidder will bear all costs for removal of papers sold to him and also the expenditure incurred in weighment and shredding.
- (v) A sum of Rs.500/- (Rupees Five hundred) only shall be deposited in the Commission's Office by the bidder in shape of cash during the Office hours on any working day towards security deposit. The receipt shall be attached to the tender papers while applying.
- (vi) The last date for receipt of the quotation in the prescribed proforma is **2 PM** of **09.12.2021**. Tender received after the said date and time or without any of the required documents shall be liable for rejection.
