NOTIFICATION

Whereas, the State Election Commission had issued Notification to hold General Elections to PRIs, 2022 in the State for the purpose of constituting the Gram Panchayats electing Ward Members and Sarpanches vide Commission's Notification No. 246 dated 11.01.2022 and the date of filling nomination was fixed from 17.01.2022 to 21.01.2022;

Whereas, the Collector, Ganjam vide letter No. 310 Dtd.22.01.2022 has reported that nomination paper submitted by Namita Nayak for the office of Sarpanch of Ankuli Gram Panchayat under Patrapur Block was snatched away by miscreants from the Designated Officer appointed for the purpose;

Whereas, the election process of the above office is vitiated due to snatching away of nomination paper;

Now, therefore, in exercise of powers conferred under Article 243-K of the Constitution of India and Rule 13 read with Rule 18 & 47 of the Odisha Grama Panchayat Election Rules, 1965 the State Election Commission hereby appoints the following dates & time for holding General Election to the office of Sarpanch of Ankuli Gram Panchayat under Patrapur Block in Ganjam District.

3. Though 30.01.2022 is a Govt. Holiday, the Office of Election Officer shall remain open for issue and presentation of nomination.
4. Election Officer appointed under the Odisha Gram Panchayat Election Rules, 1965, Odisha Panchayat Samiti Election Rules, 1991 shall be suitably instructed.
