Department have, by order under Section 12 of the Odisha Grama Panchayat Act, 1964 published in the Official Gazette on 08.01.2022 called upon all the Gram Panchayats except Dhinkia Gram Panchayat under Ersama Block in Jagatsinghpur District in the State to elect Ward Members and Sarpanches for the purpose of constituting the Gram Panchayats;
