


1. The model code of conduct issued by the Commission will remain in force in the concerned Panchayat Samiti Constituency from 21.04.2022 to 28.05.2022.
2. The Nomination of contesting candidates except the deceased whose names have been published u/r 11 (16) on the previous occasion i.e. on 25.01.2022 shall remain valid. They shall not file nominations again and they shall be intimated about the election schedule.
3. Withdrawal of candidature is permissible only for those candidates who are going to file nomination during this period.
4. Allotment of symbol shall be done afresh in Odia alphabetical order.




