


Whereas, it has been brought to the notice of the Commission that the Hon'ble High Court of Orissa vide their order dated 18.07.2024 passed in I.A.No.8412/2024 arising out of W.P.(C) No.16094/2024 has directed that status quo as on date in respect of the office of Chairperson, Kabisuryanagar Panchayat Samiti shall be maintained till 11th September, 2024;


